ADMINISTRATION FOOT NOTES:

1. Engineer tape will be sewn at the top portion of the pile tape on each shoulder pocket for OCP or the shoulder pocket flap for MULTICAM/ACU, on top of the name tape and on each trouser cargo pocket

**Rank, Patches and the U.S. Army tape will not be worn while at CAAS. (Click here for example)

2. T-Shirts must be loose fitting cotton, **NO TIGHT FITTING**, Under Armour or other athletic shirts are not authorized

3. Unauthorized items will be held in personal baggage and secured by cadre following initial layout

4. Winter items are mandatory for October 15 - April 15 selection courses.

5. Additional clothing items are authorized (i.e. uniform, IPFU, t-shirts, undergarments etc.)

6. Candidates will be issued TA-50. Candidates are not authorized to bring any additional TA-50

7. Civilian Clothes (Roughs)

Ensure your civilian attire is seasonally appropriate. Khakis with a collared shirt is considered appropriate. Jeans are not authorized. All clothing should fit comfortably and be gender appropriate. Clothing should not be ill fitting. Hiking boots are authorized, but military issued footwear is not. During cold weather months (15 October - 15 April), bring a civilian cold weather jacket that presents a professional appearance.

Do

- Wear a collared or button up shirt
- Wear a belt with conservative buckle
- Wear shoes that are comfortable and have soles conducive to running

Don't

- Wear shorts, mini skirts
- Wear low cut tops
- Wear worn or tattered clothes (no holes)
- Wear items that will draw negative attention to you

8. Candidates will travel to CAAS with the following items in a carry on bag

- IPFU with running shoes
- Uniform with engineer tape and boots
- All In Processing paperwork

9. Candidates will not need a duty uniform with name, rank, patches or headgear during the course

THESE ITEMS WILL BE SECURED BY CADRE UPON ARRIVAL AND RETURNED UPON COURSE COMPLETION

1. CELLULAR PHONE/ELECTRONIC ITEMS
2. ANY PRODUCT CONTAINING CAFFEINE
3. TOBACCO PRODUCTS OF ANY TYPE
4. CIVILIAN LONG UNDERWEAR
5. CONTACT LENSES
6. MODIFIED SHOULDER STRAPS, OR KIDNEY PADS
7. SPANDEX, ATHLETIC WEAR/UNDERWEAR (i.e. TIGHT FITTING UNDERARMOR)
8. SUPPLEMENTS, VITAMINS, ENERGY PRODUCTS OF ANY TYPE
9. GORTEX SOCKS
10. CIVILIAN MEDICATIONS (I.E. ASPIRIN, TYLENOL)
11. TA 50 OTHER THAN ONE (1) TWO QT CANTEEN AND TWO (2) ONE QT CANTEENS
12. NO KINESIOLOGY OR KT TAPE
